Bill Kolstad with "Kody"

Bill Kolstad contributed greatly to our sport of retriever field trials for over 30 years. He passed away this past January at the age of 68 following a courageous struggle against cancer.

Over the years Bill and his wife Lorna have had several very talented Labradors including FC AFC Foxfires Slight of Hand (Magic) and Bill's Double Header Winner Foxfires Lakoda Warrior (Kody) pictured with Bill.

Bill was a member of the Southern California Retriever Club and Mission Valley Retriever Club. He was a director of the SCRC for over 25 years serving as president several times, most recently for a ten year period. He also served as director of the California Retriever Training Association for ten years; was instrumental in the development of the Goose Lake training grounds and was responsible for designing the training pond that bears his name.

Bill could always be counted upon to work, to marshal, shoot, serve as the bird steward, clean out the trailer—whatever it took to put on the event. He could and would do it all. He worked many West Coast National Retriever Club and National Amateur Retriever Club Cham-

pionships, serving on various committees and as the Bird Stewards' Committee Chairman on a half dozen championships. He was to serve as chairman of the Marshals Committee for this year's NRC's Championship.

Bill was respected as a competitive sportsperson, capable handler and knowledgeable judge. He judged well over 50 major stakes including the 2002 National Retriever Club Championship and was scheduled to judge this year's National Amateur Retriever Club Championship.

Bill & Lorna, with partners, purchased and developed training grounds in both the Niland, California and Ronan, Montana areas. Over the years they have most generously made them available to trainers and for trials. Bill was especially good at welcoming newcomers to our sport and helping them with their training.

We are pleased to dedicate this year's National Retriever Club's Championship in grateful appreciation to Bill Kolstad.

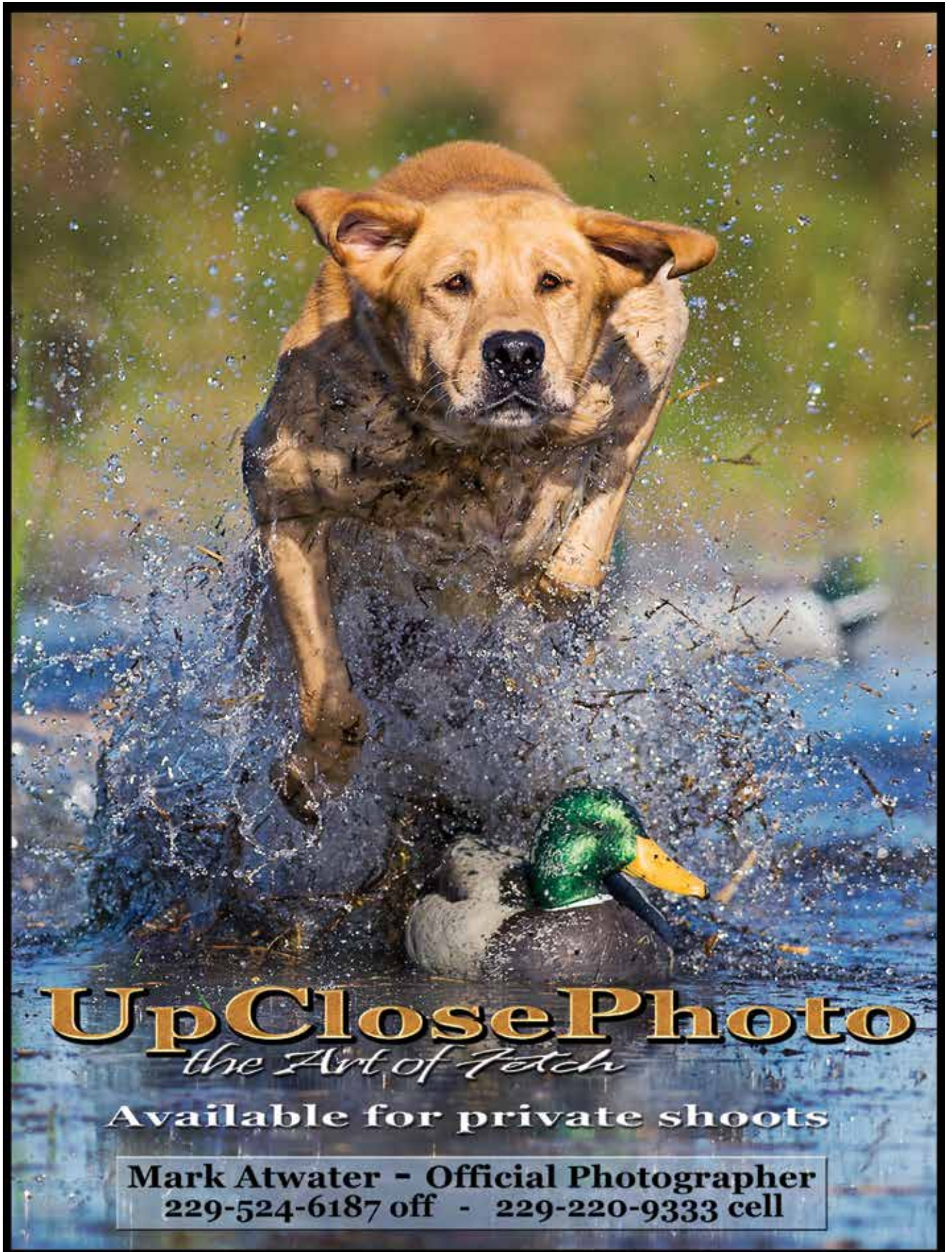

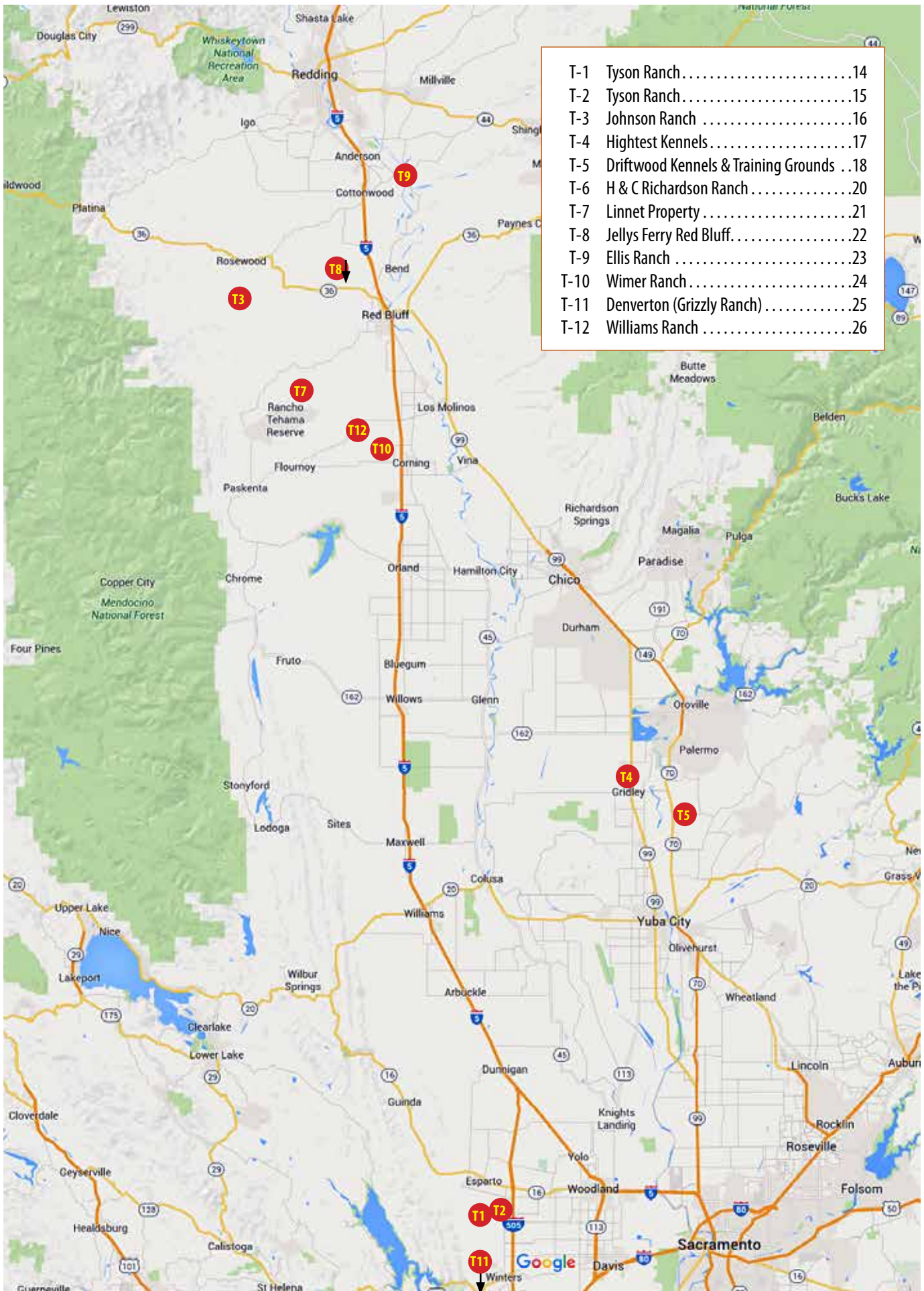

Training Sites Guidelines

Our thanks to the landowners who have opened their farms and ranches to us! Please be respectful and careful with everything you do.

We are fortunate to have some wonderful properties to use for pre-national training. Please be considerate and leave the properties as you found them. If you meet a landowner make sure you thank them, because without them there would be no pre-national training grounds. If you are having difficulty locating one of the training properties, call Chris Hatch, (530) 990-4425.

Training areas will be available and will be allocated each day by lottery drawing starting Monday, November 2 through Friday, November 6. The drawing will take place at The Inn at 5:30 PM each evening. Please take note that any dog that is qualified for the NRC will not be allowed to train on any of the grounds used for the trial within 30 days prior to the start of the trial. Any violations will be subject to disqualification.

General rules for all of the listed training grounds:

- Close all gates that you open. Some areas have locked gates. IF you draw one of these areas be sure you get the combination immediately after the draw is complete. Lock combinations will not be published.
- No smoking on training properties due to extreme fire hazard. No grilling or fires.
- Stay on roads whenever possible. Be careful where you park that weeds are not touching your mufflers. Be safe: walk your setup to avoid any injuries or hazards.
- Pack out trash. Pick up all shot gun shells.
- Please invite others to join you if your group is smaller—it's a great way to make long distance friends.

Driftwood Kennels and Training Grounds were formed to provide suitable grounds for training of retriever dogs. The current grounds in operation is located in Yuba county:

General Requirements

- Keep the area clean. Take out what you bring in. Pick up after your dog.
- Entrants are expected to conduct themselves in a proper, responsible and sportsmanlike manner while on DKTG grounds.
- Dogs must always be under control; aggressive dogs and dog fights will not be tolerated and may be permanently banned from the training grounds.
- No smoking. Smoking is not permitted on the grounds.
- Parking is not permitted in high grass areas. Please park on dirt or driven trails.
- Entrants must not under suspension by AKC. Must be of good character.
- Children (under 18 years of age) may train retrievers when accompanied by an adult.
- Minor children must wear safety glasses and ear protection when shooting and/or throwing.
- Additional caution must be taken when training near ponds especially with children and dogs.
- The adult accompanying the minor is fully responsible for that child's conduct and safety, and will be additionally responsible for any liability and/or damage resulting from the minor's use of the grounds.
- No recent occasion of any of the following:
 - Abuse of a dog
 - Abuse of grounds

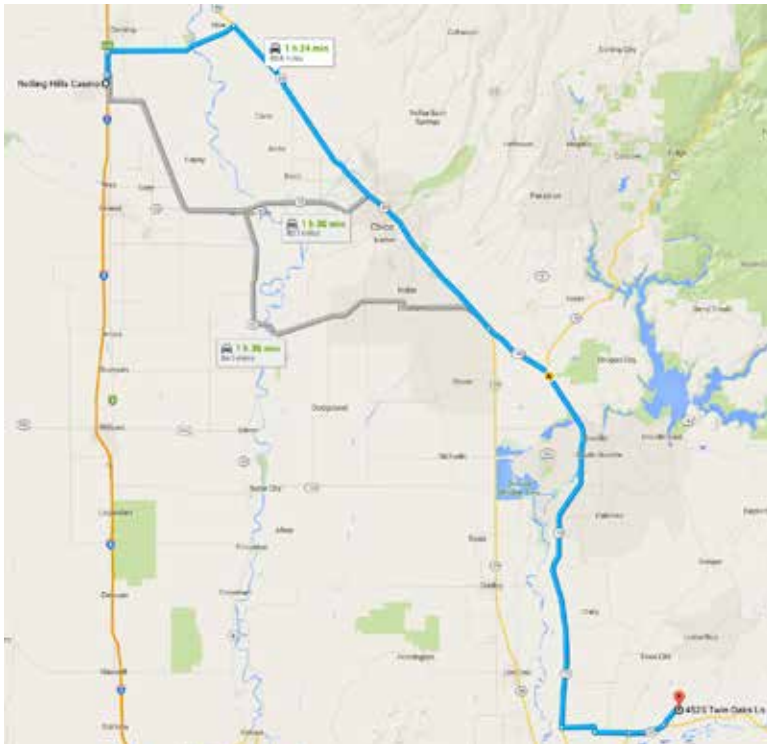

Additionally

- Lead shot shall not be used on any DKTG property.
- No hunting for wild birds or animals is permitted on the grounds.
The present California DF&G regulations require that persons shooting domestically reared game bird species (pheasants, partridge, chukar and ducks) have a valid California hunting license. Also a current upland stamp is required if shooting pheasants, partridge or chukar. A waterfowl stamp is not presently required for shooting domestically reared ducks.
- No alcohol consumption or use of drugs on the grounds.
- No motorized equipment is to be driven on the observation mounds. The maximum speed allowed shall be no greater than 10 MPH.
- The owners of DKTG may, should they deem it desirable, change or add to the "Rules Governing Use of DKTG Grounds".
- Suspension or expulsion from the grounds may be recommended at any time by owners.
- A limit may be set on the number of trainers permitted on the property at any given time.

Prior to entering the grounds the first time in each calendar year, every entrant must sign and deliver to DKTG the DKTG "hold harmless" agreement protecting the property owners and DKTG and its officers and directors from property damage and public liability. **Forms will be available and delivery can be made at the entrance to the grounds.** In addition, Entrants will be responsible for any liability and/or damage resulting from their use or their guests' use of the grounds.

At the fork in the road stay to the right, look for entrance signs.



There are THREE areas here:

- #1 Directly on right 15-20 acres pasture and trees with seasonal creek (picture attached with trees & gate up front)
- #2 Drive onto property, go several hundred yards to a gate on the left (park at gate) enter through gate to pond area - about 15 acres with nice pond. (Picture with pond)
- #3 Drive straight ahead on road through fields, stay to the right around the planted alfalfa to a large undeveloped field on the left 25-30 acres natural habitat. FLYERS ARE OK IN THIS AREA ONLY

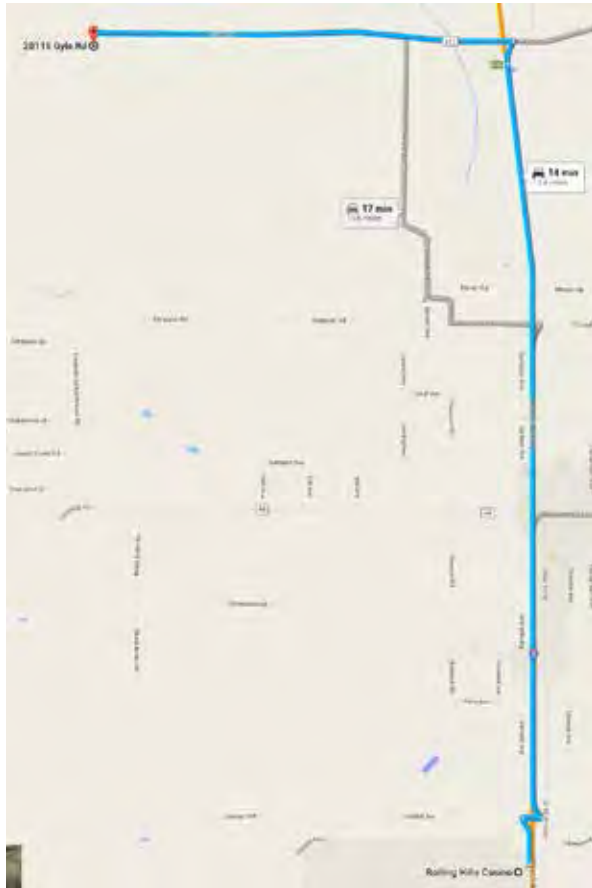

From Corning, drive north on I-5 several miles; take the Los Molinos/Tehama Exit (exit 636). Turn west over the freeway and continue west for approximately 6 miles (estimated). You will be on Gyle Road. There is no address for this property. Watch for the training sign on the roadway shoulder to mark your left turn onto a dirt road (there is a large ranch on the right just past your turn). Turn left at the signs (Torri Road) and drive up the dirt road, following the signs. Stay left at the fork drive down left past the homes and you'll see the pond tucked into the hillside on the right.

Note: Stay on this side of the pond. Don't drive past the pond. It will accommodate one small training group. No trucks with trailer as there is no room to turn around. Flyers are okay to shoot in the direction of the pond and freeway, not back towards the homes.

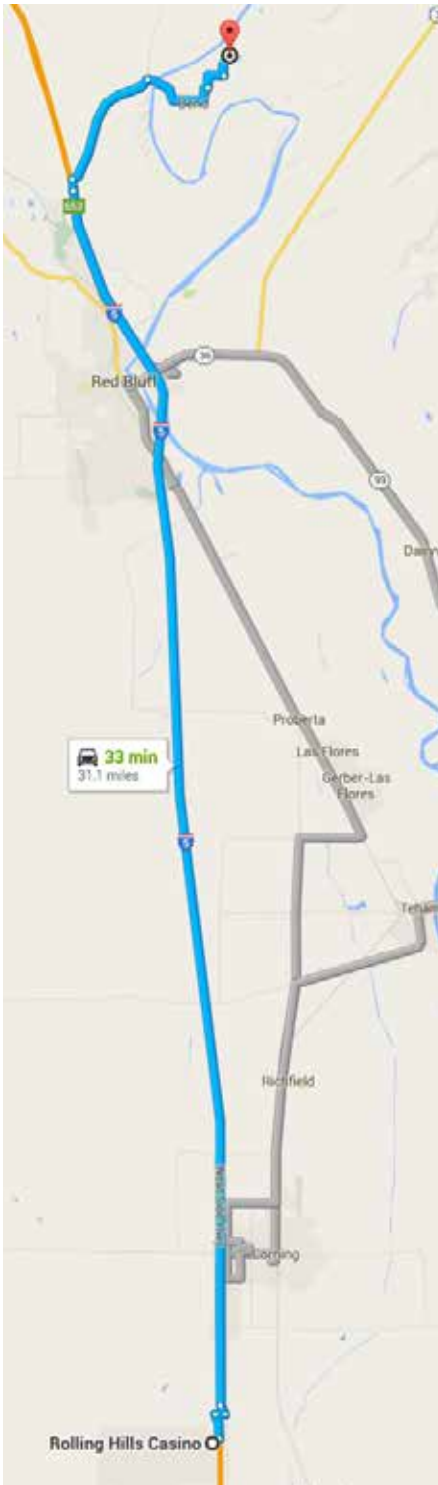

Jellys Ferry is thousands of acres of BLM lands that are readily accessible off I-5, and can support many training groups. This is a first come, first served and there will be NO drawing for areas for Jellys Ferry, as it is open to the public, so no reservations can be made.

Directions from Corning

From Corning take I-5 North. Just past Red Bluff, take the Jellys Ferry exit. Follow this road to a right turn at Bend Ferry Road. Turn right and continue driving through a rural, residential area to where the road enters the BLM property.

There are several large ponds on the property. It is unknown as to how much water will be left in them. The area is public property, open also to hikers and horsebackriders. No motorized vehicles are allowed off the main road, but there are plenty of paved turnouts with access to large fields for land work. Flyers are allowed, but extreme caution is advised due to possible hikers in the area.

Dry camping is allowed.

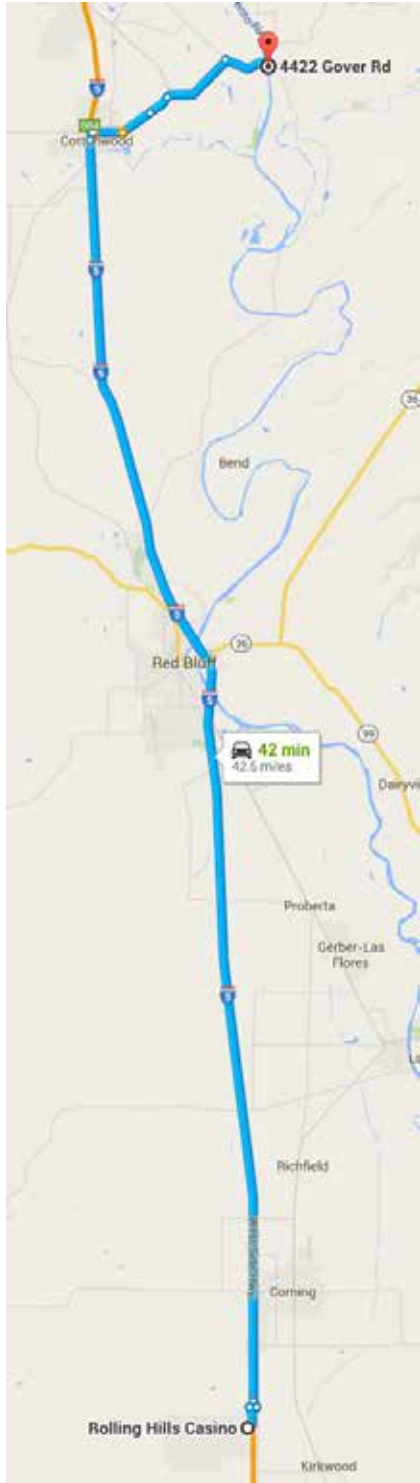

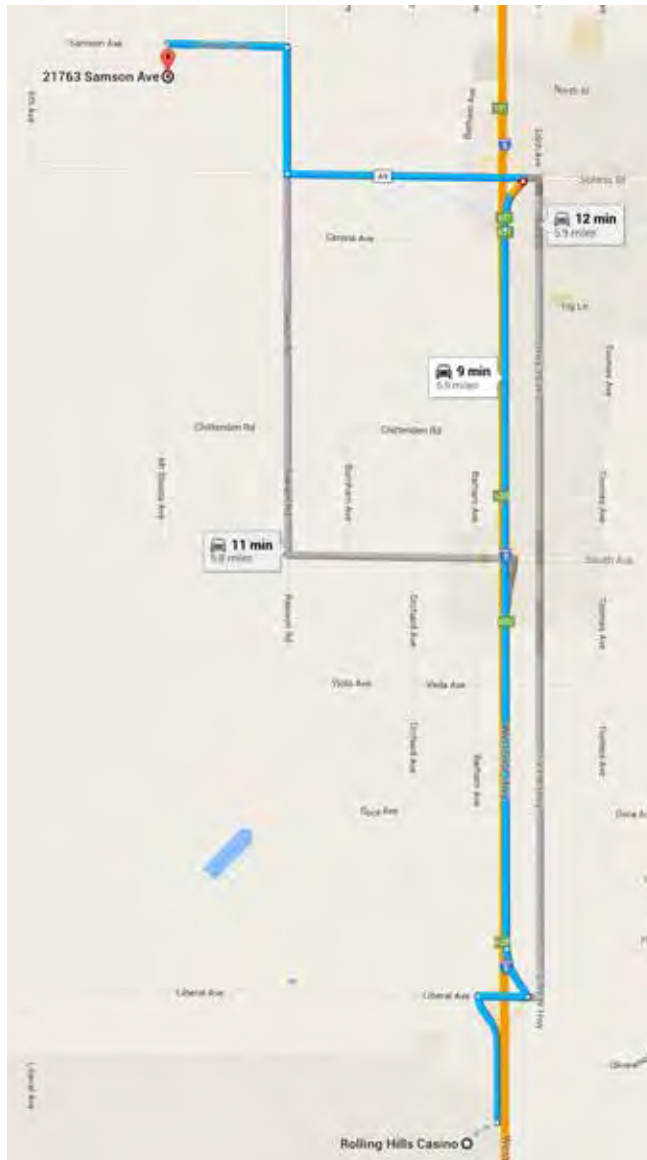

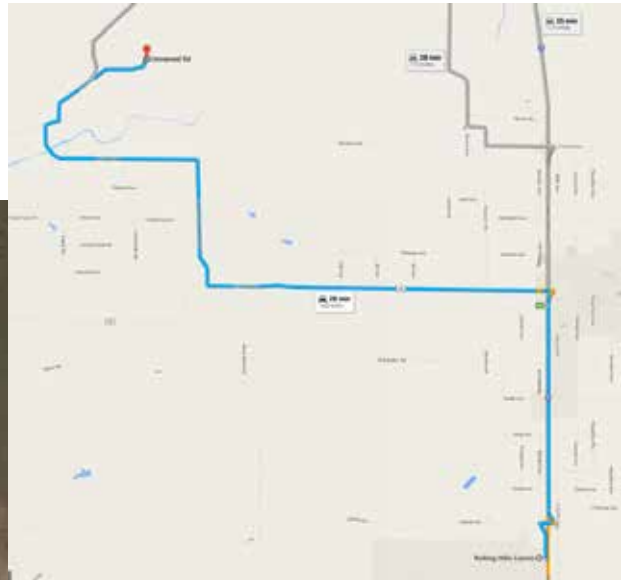

This is a large property and can support up to five training groups.

Watch for rattlesnakes, mountain lions, wild pigs, and coyotes. No smoking anywhere on the property. Flyers are okay, but please don't shoot around the power lines.
