Training Property Guidelines

The following "Guidelines" list important considerations for the use of the pre-National Training Grounds, thanks to the generosity of the owners, are available for our use. These are in no way meant to cover every possible consideration. When in doubt, use common sense and courtesy. Remember, we are invited guests on these properties. The Training Property sites are open from 8 am to 5 pm.

1. The properties listed in the Training Guide are all private grounds. We are their guests and should act accordingly.
2. The use of these grounds shall be coordinated through the Field Trial Committee and the random draws for property use.
3. No one may contact owners for individual or group use or access these properties except through the FT Committee.
4. The regulations listed for each property are in addition to these general guidelines.
5. Unless instructed otherwise close and secure all gates at all times.
6. Keep vehicles to the edges of fields and away from pond banks. Access fields only with UTV's or 4-wheelers and when wet walk into all grounds.
7. Be wary of livestock and neighbors. Never shoot in the direction of any visible livestock or residence.
8. Unless otherwise noted, smoking on any property is prohibited, except in a closed vehicle.
9. Remove all of your trash, including spent shells, dead birds and any other trash you find. Do not leave food scraps or spilled dog food on the grounds. Some properties specifically prohibit feeding on the grounds.
10. Stay well-away from residences.
11. Dead birds must be disposed of in plastic bags in approved trash containers or may be dropped at the National Trial Grounds where they will be disposed of properly.
12. By entering any of these properties you acknowledge the risks inherent in outdoor sports whether such risks are apparent or hidden. All participants accept those risks and agree that they alone are responsible for the health and safety for themselves and others in their group. Participants, by their use of the properties, acknowledge that they hold the property owners, NRDC, its officers and members harmless and free of any liability for any accidents, injuries or damage to their persons or vehicles. Entering any the properties is further subject to the participants' agreement to be held fully responsible for any damage, accidental or otherwise, to the property and any animals, facilities, buildings or equipment located on the property.
13. Enjoy these wonderful properties. But, please, be courteous to the landowners and their neighbors.

Note: For all properties in the Training Guide – No driving trucks on pond dams. Please use ATVs or walk-in.

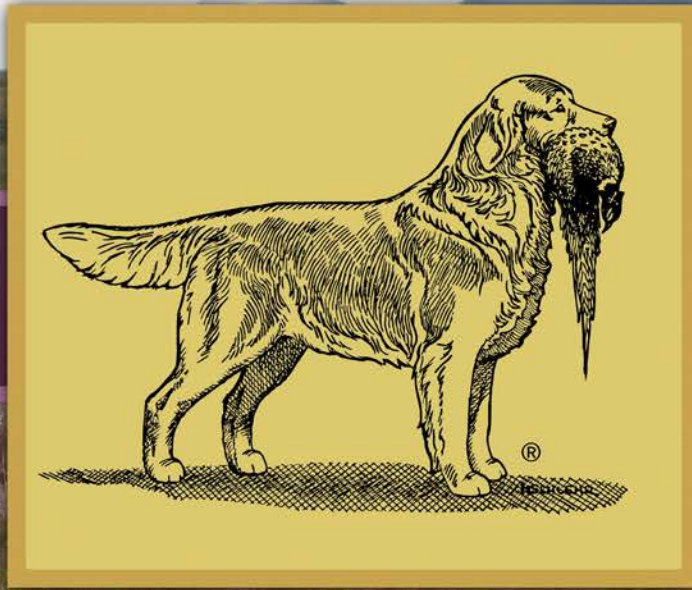

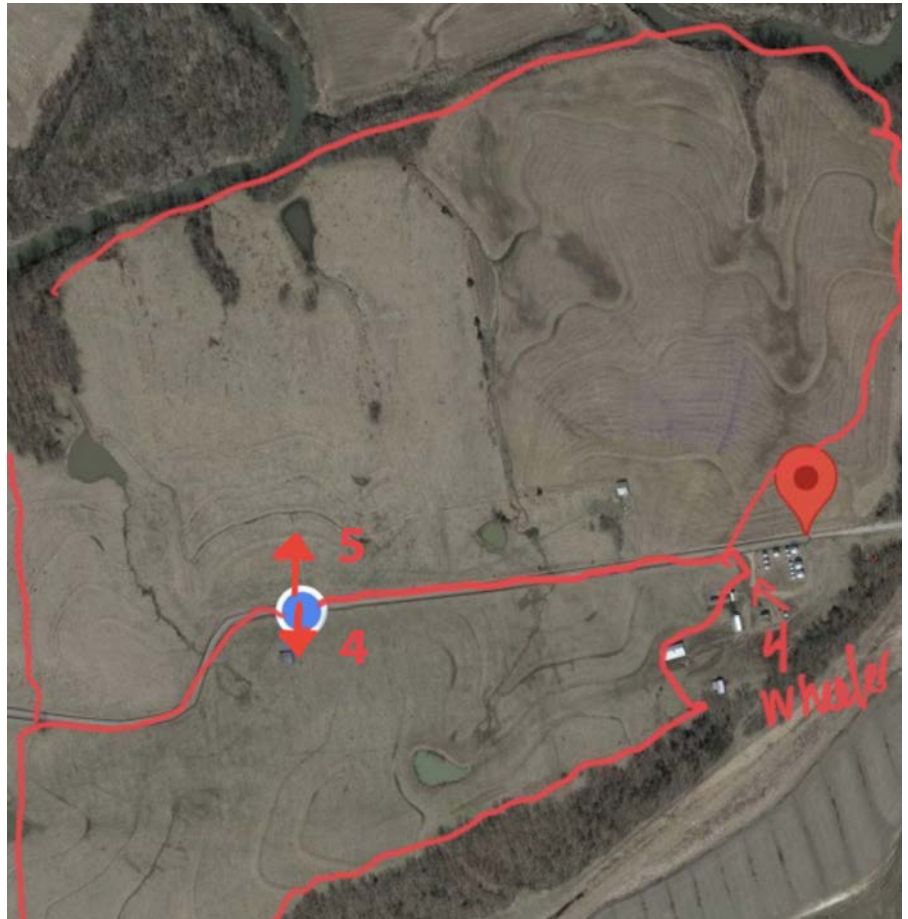
Directions: You may enter this address into Google.

Head toward Bob Hayden's, Take Right onto Hwy HH to MO-135, turn left. Take 1.9 miles to Hwy BB, turn right. 0.2 miles to Mt. Moriah Road turn left, 1.1 miles and make slight right onto conservation drive, 0.6 miles and turn onto society Lane and go 1.2 miles.

There are two properties: On the right **Property #4** has an open gate. You may keep this gate open. It is a rolling pasture sloping up with some additional terrain on a hillside.

On the left is a closed gate. There are cattle on this side. Please close the gate while you are using this side. This is another pasture. From the gate you over look a fairly large pasture that drops off with good terrain. To the right of the gate there is a small pond. The property is large enough that there is plenty to do even with the cattle on it.

As you drive past the two gates, you will find a number of small silos and a small house on the right. Just as you enter there is a four-wheeler that has been generously made available for those that might need it.

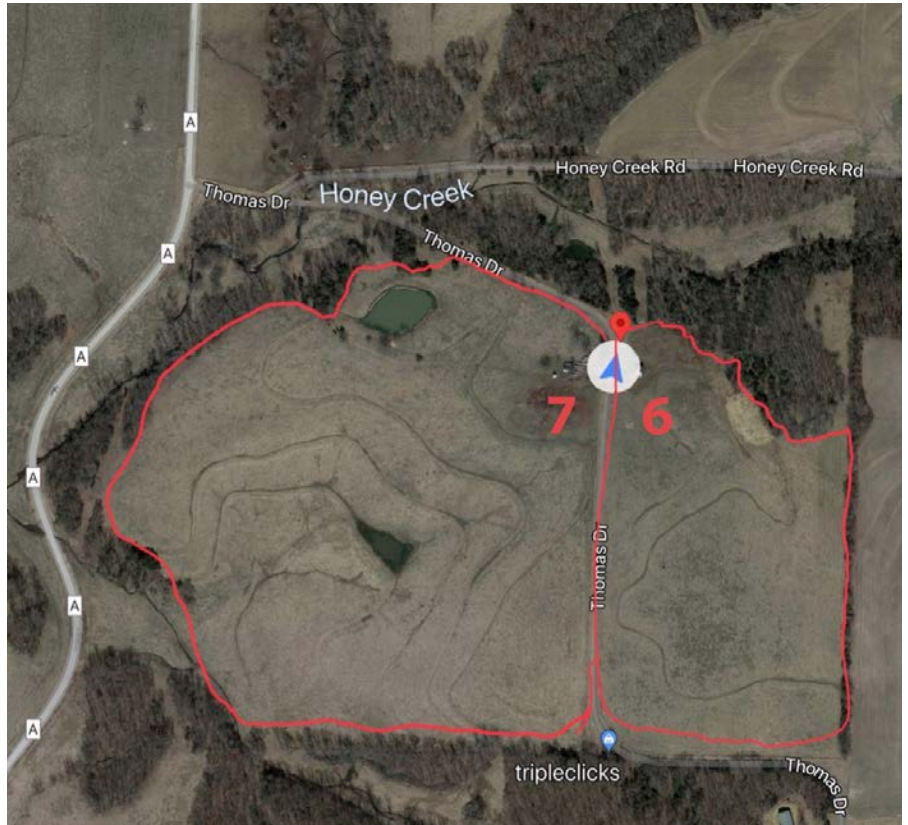
Property Description: Property 6 is a rolling meadow that rises to a tree line. Property 7 is a large meadow with two ponds and an area that terraces. (22 minutes from Bob Hayden's property)

Directions: On the way to Bob Hayden's continue on HH past hwy EE, make a left onto 135. Take 135 until you hit BB, make a left to continue on hwy 135. Take to hwy A and make a right. Go 3.3 miles and turn onto Thomas Drive. When you turn onto the road Thomas is the road that spits to the right.

You will see hay bales and a old building. Right next to these you will find the gates to enter into Properties 6 and 7.

Property 6 is on the left and Property 7 is on the right.

Please close all of the gates.

On the way to Bob Hayden's, continue on HH past hwy EE, make a left onto 135. Take 135 until you hit BB, make a left to continue on hwy 135. Take that to hwy A and make a right. Go 3.3 miles. Make a left onto Elkstown Road. Go up to the intersection of OtterCreek drive.

The gates into this property are wire fencing between cattle gate posts. One entrance is on Elkstown Rd. and the other is on Otter Creek Dr. Both are close to the intersection.

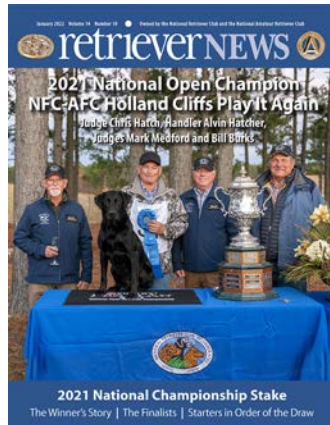

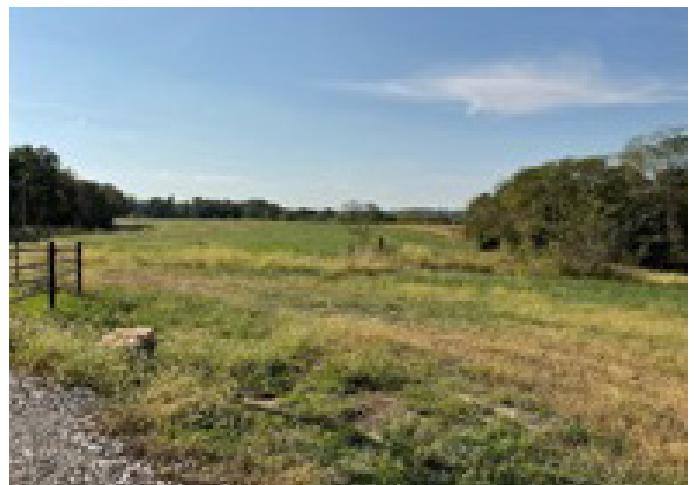
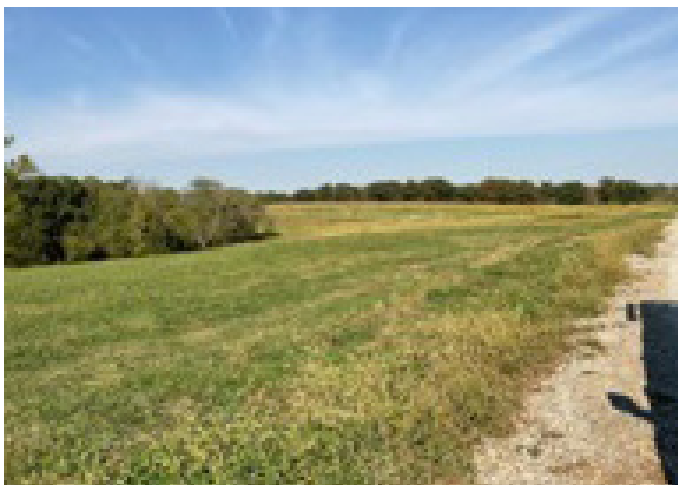

Directions: Take HH to Bob Hayden's, past Hwy EE, continue 2.8 miles to Hwy O and the second turn to Hwy O is a left hand turn.

Take Hwy O North 5.7 miles to Lookout Road and make a right turn onto Lookout Road.

Follow this 1.3 miles. You will see a gate with Starline Farms on it.

These are the fields that are cut. Longest mark is around 200 yards. The pasture does roll a little.

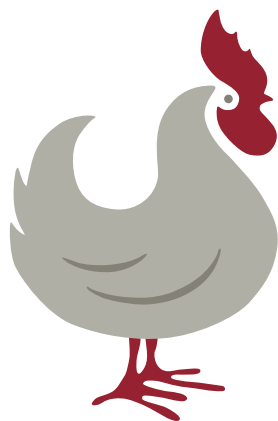
