For over three decades she worked tirelessly for the Western Montana Retriever Club, was a founding member of the Mission Valley Retriever Club and since 2004 served as secretary-treasurer. To say she was the lifeblood of our club would be a huge understatement.

Anna was also a fair and competent Judge who always set up challenging tests and made handlers feel comfortable on line. In addition to working and chairing numerous National committees, she judged the 2016 National Amateur Stake in Stowe, Vermont.

Over the years, Anna titled many dogs and ran many Nationals. She was always willing to help new trainers with expert advice and creative training tips too. In addition to training and campaigning retrievers, Anna and Larry developed a very successful, high quality breeding program.

They produced many titled dogs over the years in the US and Canada, both their own, and great dogs bought by others. If you acquired a Jazztime pup, you not only received a very well-bred retriever, you would also get a wealth of support in raising the pup and training toward a complete retriever.

Anna's quiet, pleasant personality made her approachable. She worked tirelessly to further the sport and support her clubs. However, all that was secondary to her beloved dogs. Anna absolutely loved her dogs. Everything about her existence was done with an eye toward the welfare of her many dogs. She was just a wonderful, kind and giving person. She will be missed.

John and Missy Goettl started their adventure in the retriever world in 1967.

John has been active in the retriever field trial sport as a contestant, judge, administrator, facilitator and gunner for the past fifty years. He is a past president of the Fort Collins Retriever Club (multiple times), the Rocky Mountain Field Trial Association (multiple times), and the National Amateur Retriever Club. He was inducted into the Retriever Field Trial Hall of Fame in 2017.

John served on the AKC rules sub-committee for over twenty-five years. He assisted with the conception, production, and editing of the Retriever Field Trial Judges Manual. He served on the board of directors for the Retriever Field Trial News for four years. He planned, organized and moderated numerous judging, training, and handling clinics.

John served as the Mountain Time Zone national gun captain for twenty years. He gunned at sixty-one National Championships including the last forty consecutive National Amateurs. He worked on other National Championship committees and served on the National Field Trial committees many times.

John judged over 130 field trials including fun trials, sanctioned trials, minor stakes at licensed trials, and close to sixty licensed trials carrying championship points. Additionally, he judged four National Golden Retriever Field Trial Specialties, two National Retriever Championships, and the inaugural National Derby Championship. He has had four AFC titled dogs.

While John was busy training, competing, judging and working at field trials, Missy was equally busy serving as a field trial secretary for their local clubs, entertaining and feeding judges and workers for those trials. She was a charter member, officer and longtime board member of the Colorado Womens' Retriever Club.

Missy's national hostessing efforts began as co-chair for the first Steamboat Springs National Amateur Retriever championship in 1987 and culminated as chairman for the inaugural National Derby Championship in 2017. She was chair or co-chair for the Rocky Mountain Regions NARC's as well as co-chairing and working on hostess committees in the other three time zones. Her knowledge and her written protocols have assisted many first-time hostess chairmen.

John and Missy's dedication to the retriever sport for the last half century is based on their love of dogs and respect for fellow competitors. They continue to train and participate in chosen field trials around the country, and to enjoy their two competitive dogs and their pretend retriever (English Cocker Spaniel "Tux.") They feel fortunate to still live the country life near Fort Collins, CO, and to enjoy having their daughter and family living close by.

National Amateur Championship Rotation Order

The starting dog's number will be drawn at the General Meeting the day previous to the beginning of the trial. Each rotation segment is determined by dividing the number of contestant dogs listed in the catalog by a figure of five (5). The rotation numbers will be announced prior to adjourning the General Meeting. Beginning with the starting dog selected during the meeting, this division determines the dogs that start each successive rotation, where a rotation may include more than one series. If any of the numbers are not listed in the callbacks, the next higher number will start. Unequal divisions shall be rounded up to nearest whole number.

By example, dog 25 starts a 115 dog trial. The rotational division would be 115 dogs divided by 5 which equals 23 dogs in the rotation where the rotation would be determined as follows:

Example: 115

Dogs Entered / 5 = 23:

1st - 25

2nd - 48 (= 25+23)

3rd - 71 (= 48+23)

4th - 94 (= 71+23)

5th - 2 (= 94+23)

Following the fifth rotation, the rotation returns to the starting dog of the trial (25), excluding that dog, and beginning with dog 26, or the first working dog after 26, five (5) working dogs (dogs listed on the callbacks) are counted and the sixth dog would start the sixth rotation.

Rotation for the remaining series of the trial will be, beginning with the dog that started the previous series and excluding that dog, counting five working dogs and the sixth dog would start.

No dog will start any completed series more than once. If the rotation landed on a dog that had previously started a completed series, that dog would be skipped unless all remaining dogs had already started a series and then the dog that was the first to start a series of the remaining dogs in the trial would be starting dog. The Field Trial Marshal will administer and interpret this procedure in conjunction with the Field Trial Committee.
